Notice inviting Expression Of Interest **NIQ No. 2179/PWD(BMC) Dated 28/12/2016**

“Open Table Bid” are hereby invited from licensed, bonafied, resourceful Agencies for the under mentioned work in connection with “Bidhannagar Mela (Utsav)-2017” organizes by Bidhannagar Municipal Corporation to be held at “Bidhannagar Mela Prangan” on & (from 12/01/2017 to 05/02/2017 = 25 days):

2. “Providing about 50,000 sq. ft. space for setting up **Amusement Rides** within Bidhannagar Mela Prangan in connection with Bidhannagar Mela (Utsav) –2017”.

Support Price: Rs. 20,00,000/- (Rupees twenty lakh only) (More or Less)

The applicant who has the working experience in setting up amusement rides in any Government or Government affiliated organisation within last five (5) years having a value of single work not less than **50%** of the Quoted Price can apply.

Interested Applicants are requested to attend the Table Bid on **03/01/2017 at 1.00 p.m.** in the chamber of the undersigned.

BID must be submitted in a sealed cover comprising of two sealed covers, one with the papers related to eligibility criteria i.e. credentials, PAN/IT/Service Tax/VAT/PT & other associated papers, as applicable duly attested by the applicant himself along with the **earnest money @ Rs.30,000/- (Rupees Thirty Thousand only)** in the form of Bank draft / Pay order in favour of “Bidhannagar Municipal Corporation” & other envelop with the Quotation form/Price Bid with the name of work written on the envelope(s) addressed to the undersigned.

The Price Bid cover will be opened after the opening of the eligibility criteria cover. The applicants, who will not be eligible, the Price Bid Cover/Quotation Cover of those will not be opened.

Terms & Conditions

1. The NIQ must be submitted in the sealed cover in the format attached herewith along with the page no. 1 & 2 (terms & conditions) with necessary signature & seal of the Agency.
2. The space will be provided for **Amusement Rides only**. No other business will be allowed inside.
3. All works to be **completed** within **10/01/2017** within 4.00 p.m. and to be kept in good condition upto 05/02/2016.
4. The agency might be asked to shift orientation of units within Mela Prangan and will have to execute any construction work (pavilions, stalls, food kiosks etc.) according to the departmental guidelines.
5. Necessary **Fit Certificates** from competent Authority / Authorities for all the amusement rides must be submitted by the agency before its commencement.
6. Any encroachment on roads/passages will not be allowed.
7. Before submission of NIQ, the applicant should thoroughly acquaint themselves with the local conditions by actual inspection of the sites & take into consideration all factors & no claim what-so-ever will be entertained on any of these accounts afterwards.

8. Accepting Authority does not bind himself to accept the highest quotation & reserves the right to reject any or all the NIQ received without assigning any reason whatsoever and also reserve the right to split up the work along different contractors necessary.
9. The earnest money draft of the unsuccessful applicants will be returned immediately after issuance of Work Order & for the successful applicant the same will be adjusted with the Bid Price. The Successful applicant has to deposit the **balance amount of Bid Price** in the form of Bank Draft / Pay Order in favour of 'Bidhannagar Municipal Corporation' after acceptance of his Bid & before issuance of Work Order.
10. After issuance of work order, if any applicant fails to do his work, the work order will be considered as automatically cancelled & earnest money forfeited.
11. Authority reserves the right to make any additions / changes / alterations with respect to the erection of stalls, pavilions, food kiosks during progress of the work.
12. The applicant should quote rates both in words and in figures.
13. The rate should be quoted for complete item.
14. NIQ which does not fulfill any of the above conditions or is incomplete in any respect is liable to be summarily rejected.
15. If any applicant withdraws his quotation before its acceptance for which a reasonable time without giving any satisfactory explanation for such withdrawals he shall be disqualified for submitting quotation to this department for a minimum period of one year.
16. All construction works to be done as per the latest guidelines of West Bengal Fire and Emergency Services. Necessary no objection certificates from West Bengal Fire and Emergency Services must be obtained by the agency.
17. After completion of the Mela (Utsav) the entire site must be cleared by the agency at his own cost within 7 (seven) days from the conclusion of the Mela (Utsav).
